To assert such a claim, YOU MUST COMPLETE, EXECUTE AND RETURN THIS ASBESTOS PROPERTY DAMAGE CLAIM PROOF OF CLAIM FORM BY NO LATER THAN OCTOBER 5, 2007 (THE “ASBESTOS PROPERTY DAMAGE CLAIM BAR DATE”) PURSUANT TO THE INSTRUCTIONS PROVIDED FOR HEREIN, OR YOU WILL BE FOREVER BARRED FROM ASSERTING THE ASBESTOS PROPERTY DAMAGE CLAIM AGAINST THE DEBTOR.

“Asbestos Property Damage Claim” means any claim, demand, debt or liability that has been or in the future is brought or asserted against the Debtor alleging that the Debtor has liability due to a person’s property damage (a) caused or allegedly caused, in whole or in part, directly or indirectly (i) by asbestos or asbestos-containing products installed, sold, handled, used, made, distributed, supplied, removed, or otherwise disturbed by Debtor, or (ii) by services, actions, or operations provided, completed, performed, or taken by Debtor, in connection with asbestos or asbestos-containing products, or (b) caused or allegedly caused by asbestos or asbestos-containing products for which Debtor is or may be liable under any applicable law.

INSTRUCTIONS

1. WHO SHOULD USE THIS ASBESTOS PROPERTY DAMAGE PROOF OF CLAIM FORM

You must complete this Asbestos Property Damage Claim Proof of Claim Form if you wish to assert an Asbestos Property Damage Claim against ACandS. An "Asbestos Property Damage Claim" means any claim, demand, debt or liability that has been or in the future is brought or asserted against the Debtor alleging that the Debtor has liability due to a person's property damage (a) caused or allegedly caused, in whole or in part, directly or indirectly (i) by asbestos or asbestos-containing products installed, sold, handled, used, made, distributed, supplied, removed, or otherwise disturbed by Debtor, or (ii) by services, actions, or operations provided, completed, performed, or taken by Debtor, in connection with asbestos or asbestos-containing products, or (b) caused or allegedly caused by asbestos or asbestos-containing products for which Debtor is or may be liable under any applicable law.

2. WHERE TO OBTAIN AN ASBESTOS PROPERTY DAMAGE PROOF OF CLAIM FORM AND INFORMATION FOR ASBESTOS PROPERTY DAMAGE CLAIMS

3. GENERAL INSTRUCTIONS

YOU MUST COMPLETE AND SIGN THIS ASBESTOS PROPERTY DAMAGE CLAIM PROOF OF CLAIM FORM. THE ORIGINAL, COMPLETED ASBESTOS PROPERTY DAMAGE CLAIM PROOF OF CLAIM FORM AND COPIES OF REQUIRED DOCUMENTATION MUST BE RECEIVED BY THE DEBTOR'S CLAIMS AGENT ON OR BEFORE THE ASBESTOS PROPERTY DAMAGE CLAIM BAR DATE, or you shall be forever barred, estopped, and enjoined from asserting any Asbestos Property Damage Claim against the Debtor; or voting upon, or receiving any distributions under any plans of reorganization in the Debtor's chapter 11 case in respect of such Asbestos Property Damage Claim.

This Asbestos Property Damage Claim Proof of Claim Form must be signed by you or your authorized agent. If you cannot fit all information in any particular section or page, copy the page before completing it, and attach as many additional pages as needed. Neatly type or print all answers on the form.

Be **accurate** and **truthful**. By Order of the Court, this Asbestos Property Damage Claim Proof of Claim Form is an official court document that may be used as evidence in any legal proceeding regarding your Asbestos Property Damage Claim. The penalty for presenting a fraudulent claim is a fine of up to \$500,000 or imprisonment for up to five years or both under 18 U.S.C. 152 and 3571.

4. WHERE AND HOW TO SUBMIT CLAIM FORMS

Make a copy of your completed Asbestos Property Damage Claim Proof of Claim Form for your records. Send the **original** Asbestos Property Damage Claim Proof of Claim Form and copies of all attachments to The Garden City Group, Inc., the Debtor's Claims Agent, at one of the two the following addresses:

In submitting the Asbestos Property Damage Claim Proof of Claim Form, allow sufficient time so that this form is received on or before the Asbestos Property Damage Claim Bar Date. Asbestos Property Damage Claim Proof of Claim Forms that are postmarked **before** the Asbestos Property Damage Claim Bar Date but **received** after the Asbestos Property Damage Claim Bar Date will not be accepted. Only original Asbestos Property Damage Claim Proof of Claim Forms will be accepted for filing. Asbestos Property Damage Claim Proof of Claim Forms transmitted by facsimile or e-mail will not be accepted and will not be deemed filed.

5. **ADDITIONAL DOCUMENTATION AND INFORMATION**

In addition to the completed, original Asbestos Property Damage Claim Proof of Claim Form, you must provide copies of all supporting documents in your possession referenced in Questions 1-10, or you may provide summaries of those documents if they are voluminous. If documents are not available, you must attach an explanation of why they are not available.

You may attach any additional documentation that supports your Asbestos Property Damage Claim. However, such information will not be a substitute for information provided in the Asbestos Property Damage Claim Proof of Claim Form itself.

6. **DEADLINE FOR RECEIPT OF ASBESTOS PROPERTY DAMAGE CLAIM PROOF OF CLAIM FORMS**

Asbestos Property Damage Claim Proof of Claim Forms must be **received** by the Claims Agent at one of the addresses noted above in paragraph 4 on or before the Asbestos Property Damage Claim Bar Date.
